We have conducted the review of the compliance of the applicable statutory provisions and the adherence to good corporate practices by Dharmaj Crop Guard Limited (hereinafter referred as 'the listed entity'), having its Registered Office at Plot No. 408 to 411, Kerala GIDC Estate, Off NH-8, At: Kerala, Bavla, Ahmedabad 382220, Gujarat. The Equity Shares of the Company were listed on National Stock Exchange of India Limited and BSE Limited ("Stock Exchanges") w.e.f December 8, 2022.
