With reference to the captioned subject, we would like to inform that yesterday on 28th July 2023, we have received a notice from Advocate on behalf of SML Limited, through email wherein it was communicated that an ex-parte ad-interim order has been passed on July 24, 2023 by the Single Judge of the Himachal Pradesh High Court in a patent infringement suit no. COMS NO.7 of 2023& OMP NO. 324 of 2023, pursuant to which, the Company has been temporarily restrained from making, using, selling, offering for sale, advertising, marketing, importing or exporting the product "Zeekasulf". Despite of the fact that we didn't sold "Zeekasulf" in Himachal Pradesh and we don't have any Direct business dealing with Defendant no: -1 as mentioned in the order.

We would like to state that Company is dealing in diverse products and product portfolio consist of 121 products and contribution into turnover of this particular product is not material and Company is building up its product portfolio by 5 to 6 new products every year. The estimated revenue of "Zeekasulf" for the FY 23-24 is expected to be below 2% of the total expected turnover of the Company. Consequently, there will not be significant adverse impact on the turnover or profitability of the Company.

We as a Company will take care about the Order and take the appropriate legal recourse in this matter.

We are giving details pursuant to the intimation and order received, as required under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13th July, 2023 in Annexure **A**.
